



Application for ArtWalk Event Permit

Thank you for your interest in participation in First Friday ArtWalk. Please read through these pages carefully, as there are important times, fees, and guidelines for participation.

Permits: All Participants will be required to obtain an ArtWalk Participation Permit from ACK for each First Friday ArtWalk. Permits and location assignments will be randomly assigned for single month applicants at time of set-up. Multiple month applicants may secure their spaces for the duration of their contracts. Applicants must apply for their First Friday ArtWalk Permits and meet specific requirements (*See permit application requirements below*) prior to receiving permits.

NOTE: The Arts Council of Kern has acquired all Bakersfield City permits and paid all City fees for ArtWalk Participants. Permits include all Bakersfield City permits, a 10x5 assigned space (tables, chairs etc. not included), and licensed security officers when streets are open.

**** ALL VENDORS MUST REGISTER AND PAY THE FEE BY 4PM ON THE WEDNESDAY PRIOR TO THAT MONTH'S ARTWALK. ****

Keep your permit with you at each First Friday ArtWalk during set-up 3:30 pm-5 pm, event 5 pm – 9 pm, and breakdown 9 pm-10 pm. Set-up begins no earlier than 3:30 pm on the day of the event. Participants must move cars from blocking the streets after set-up and set-up displays must not block sidewalk pedestrian flow. Permits are non-transferable without prior arrangements and approval by the Arts Council of Kern. Participants may not block business doorways and must leave their spaces as found when they arrived. All displays, trash, tables, and chairs must be removed no later than 10 pm on all First Friday ArtWalks.

ACCIDENT WAIVER AND RELEASE OF LIABILITY

I HEREBY ASSUME ALL OF THE RISKS OF PARTICIPATING IN ANY ACTIVITIES ASSOCIATED WITH THE ARTWALK AT FIRST FRIDAY, including for example and not limited to, any risks that may arise from negligence or carelessness by the persons or entities being released, from dangerous or defective equipment or property owned, maintained, or controlled by them, or because of their possible liability without fault. In consideration of my application and permitting me to participate in THE ARTWALK, I take action for myself, my executors, administrators, heirs, next of kin, successors, and assigns to:

(A) WAIVE, RELEASE, AND DISCHARGE from any liability, including but not limited to, liability arising from the negligence or fault of the entities or persons released, for my death, disability, personal injury, property damage, property theft, or actions of any kind which may hereafter occur including my traveling to and from this activity, THE ARTS COUNCIL OF KERN, its directors, officers, employees, volunteers, representatives, and agents, and the activity holders, sponsors, and volunteers;

(B) INDEMNIFY, HOLD HARMLESS, AND PROMISE NOT TO SUE THE ARTS COUNCIL OF KERN, its directors, officers, employees, volunteers, representatives, and agents, and the activity holders, sponsors, and volunteers. This indemnity extends to any liabilities or claims made because of participation in this activity, whether caused by the negligence of THE ARTS COUNCIL OF KERN or any other person or entity.

THE ARTS COUNCIL OF KERN, its directors, officers, volunteers, representatives, and agents are NOT responsible for the errors, omissions, acts, or failures to act of any party or entity conducting a specific activity on their behalf.

This activity takes place on open public streets with unrestricted vehicular and pedestrian traffic and is attended by the public with no limitation on who may attend. As such this event has the possibility of injury, including potential for death, serious injury, and property loss as a risk of being on public streets, with the public, and in the presence of automobiles. The activity takes place outdoors and has the risks associated with terrain, facilities, temperature, weather, condition of participants, equipment, lack of hydration, and actions of other people including, but not limited to, participants, volunteers, monitors, and/or producers of the activity. These risks are not only inherent to participants but are also present for volunteers. I understand that I need to take appropriate precautions and provide for myself anything necessary to protect from weather including shade and hydration.

I understand while participating in this activity, I may be photographed. I agree to allow my photo, video, or film likeness to be used for any legitimate purpose by the activity holders, producers, sponsors, organizers, and assigns.

The Accident Waiver and Release of Liability Form shall be construed broadly to provide a release and waiver to the maximum extent permissible under law.

I CERTIFY THAT I HAVE READ THIS DOCUMENT AND I FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY AND A CONTRACT. I AM AWARE THAT IT CONSTITUTES AN EXPRESS AND VOLUNTARY ASSUMPTION OF ALL RISKS ASSOCIATED WITH THE ARTWALK. AND I SIGN IT OF MY OWN FREE WILL.
